RESOLUTION

WHEREAS, by Resolution No. 14-4680, adopted on August 21, 2014, the Board of Commissioners ("Board") of the Memphis-Shelby County Airport Authority ("Airport Authority") authorized the execution of a multi-year contract with Parsons Transportation Group, Inc. to provide construction administration, inspection, and program management services in support of the Authority's Capital Improvement Program for the project described as:

**CONSTRUCTION ADMINISTRATION,
INSPECTION AND PROGRAM MANAGEMENT SERVICES
PROFESSIONAL ENGINEERING SERVICES
MSCAA PROJECT NO. 14-1372-00**

WHEREAS, Contract No. 14-1372-00 was executed effective September 1, 2014 ("Contract"); and established a scope of services with commensurate unit billing rates and a not-to-exceed budget for the first contract year of \$3,200,000; and,

WHEREAS, Article 1, Section 1.02, (a) of the Contract, provides for annual adjustment of unit billing rates; requires establishment of an estimated not-to-exceed budget for each successive contract year; and requires incorporation of the written amendment into the contract agreement; and,

WHEREAS, by Resolution No. 15-4722, adopted on August 20, 2015, the Board authorized Contract Amendment No. 1 to establish an estimated not-to-exceed budget for the second contract year of \$3,200,000; and,

WHEREAS, by Resolution No. 16-4755, adopted on August 18, 2016, the Board authorized Contract Amendment No. 2 to establish an estimated not-to-exceed budget for the third contract year of \$3,000,000; and,

WHEREAS, Airport Authority Management now desires to exercise the first of two options-to-renew the Contract for a fourth year; and,

WHEREAS, Airport Authority Management has negotiated billing rates for the fourth year of the Contract and an estimated not-to-exceed budget in the amount of \$4,300,000, which is based on currently active and anticipated projects and will be tracked by specific project and expenditures; and,

WHEREAS, in furtherance of its Disadvantaged Business Enterprise (DBE) Program, the Airport Authority established a DBE goal of 25% for the full term of this contract; and,

WHEREAS, the Airport Authority's Capital Program Executive Staff, by action taken on July 27, 2017, recommends approval of Amendment No. 3 to Contract No. 14-1372-00; and,

WHEREAS, Management recommends approval of Contract Amendment No. 3 effective September 1, 2017;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of the Memphis-Shelby County Airport Authority, that the President and CEO or his designee is hereby authorized to execute Amendment No. 3 to Contract No. 14-1372-00 with Parsons Transportation Group, Inc., as herein described, effective September 1, 2017, cost to be paid from various funding sources based on related, approved and designated projects or other funding identified by the CFO.

WHEREAS, by Resolution No. 16-4767, adopted October 20, 2016, the Board of Commissioners ("Board") of the Memphis-Shelby County Airport Authority ("Airport Authority") authorized the negotiation of a contract with Jacobsen/Daniels Associates, LLC to provide Airport Master Plan services for Memphis International, General DeWitt Spain, and Charles W. Baker Airports, described as:

WHEREAS, the scope of services under this project will generally consist of, but not be limited to, preparation of a new sustainable Master Plan for Memphis International Airport to reflect industry changes, update forecast and growth projections, and establish airport priorities while taking into consideration recent and pending improvements to airport facilities and infrastructure with an option to include similar services at General DeWitt Spain and/or Charles W. Baker Airports; and,

WHEREAS, the Airport Authority has negotiated fees for services to be performed by Jacobsen/Daniels Associates, LLC ("Contractor") and desires to execute a contract with Jacobsen/Daniels Associates, LLC; and,

WHEREAS, the new Master Plan will be prepared in accordance with FAA AC No. 150/5070-6B, as revised, and will define the future air cargo and passenger aviation needs of the airport and the best alternatives for implementation; and,

WHEREAS, the project will be a two-part phased contract: the first phase will require the Contractor to define the goals and objectives of the Master Plan, gather data, engage stakeholders, and prepare forecasts necessary to define facility requirements for the study period; and, the second phase will require the Contractor to develop and evaluate all of the alternatives available to meet the projected requirements, and prepare an implementation plan and associated financial feasibility analysis; and,

WHEREAS, the Master Plan will also include tasks for: a Public Involvement Program; coordination with other teams preparing designs and assessments of airport facilities; Terminal Master Plan; Airside Master Plan; benefit cost analysis; Stormwater Management Master Plan; Master Plan Report, and Airport Layout Plans; and,

WHEREAS, other professional aviation and related planning services may be included in the contract under separate task orders; and,

WHEREAS, in furtherance of its Disadvantaged Business Enterprise (DBE) Program, the Airport Authority established a DBE goal of 27% for the full term of this contract; and,

WHEREAS, the following fees have been negotiated for the professional services:

RESOLUTION

WHEREAS, in accordance with state law requirements, the Memphis-Shelby County Airport Authority ("Airport Authority" or "MSCAA") is authorized by the public purchasing provisions of state law to participate in the cooperative purchasing of supplies and/or services; and,

WHEREAS, the Airport Authority approved purchases pursuant to the Master Intergovernmental Cooperative Purchasing Agreement ("Agreement") with the National Intergovernmental Purchasing Alliance Company ("IPA"); and,

WHEREAS, IPA acquired The Cooperative Purchasing Network ("TCPN") in 2015; and,

WHEREAS, in early 2013, the Airport Authority opened the Consolidate Rental Car Facility located on the first two floors of the Ground Transportation Center which included a customer service building, ready and return car operations, and a quick turn-around wash and fueling facility in support of rental car operators at Memphis International Airport (Airport); and,

WHEREAS, at the request of rental car operators operating at the Airport, the Airport Authority investigated security systems, compatible with existing systems, that could enhance security and benefit operators at the airport; and,

WHEREAS, pursuant to the Agreement, the Airport Authority desires to purchase a security system consisting of a closed-circuit television ("CCTV") infrastructure that includes License Plate Recognition (LPR) capabilities for the rental car quick turnaround area located in the Ground Transportation Center; and,

WHEREAS, an agreement will be entered into under the National IPA # R170504 with Schneider Electric, Inc. ("Schneider"); and,

WHEREAS, the contract will include hardware, software, cabling, installation, and warranty for two years for a total cost of one hundred seventy-eight thousand, four hundred ninety-three (\$178,493.00) dollars; and,

WHEREAS, Airport Management recommends approval;
