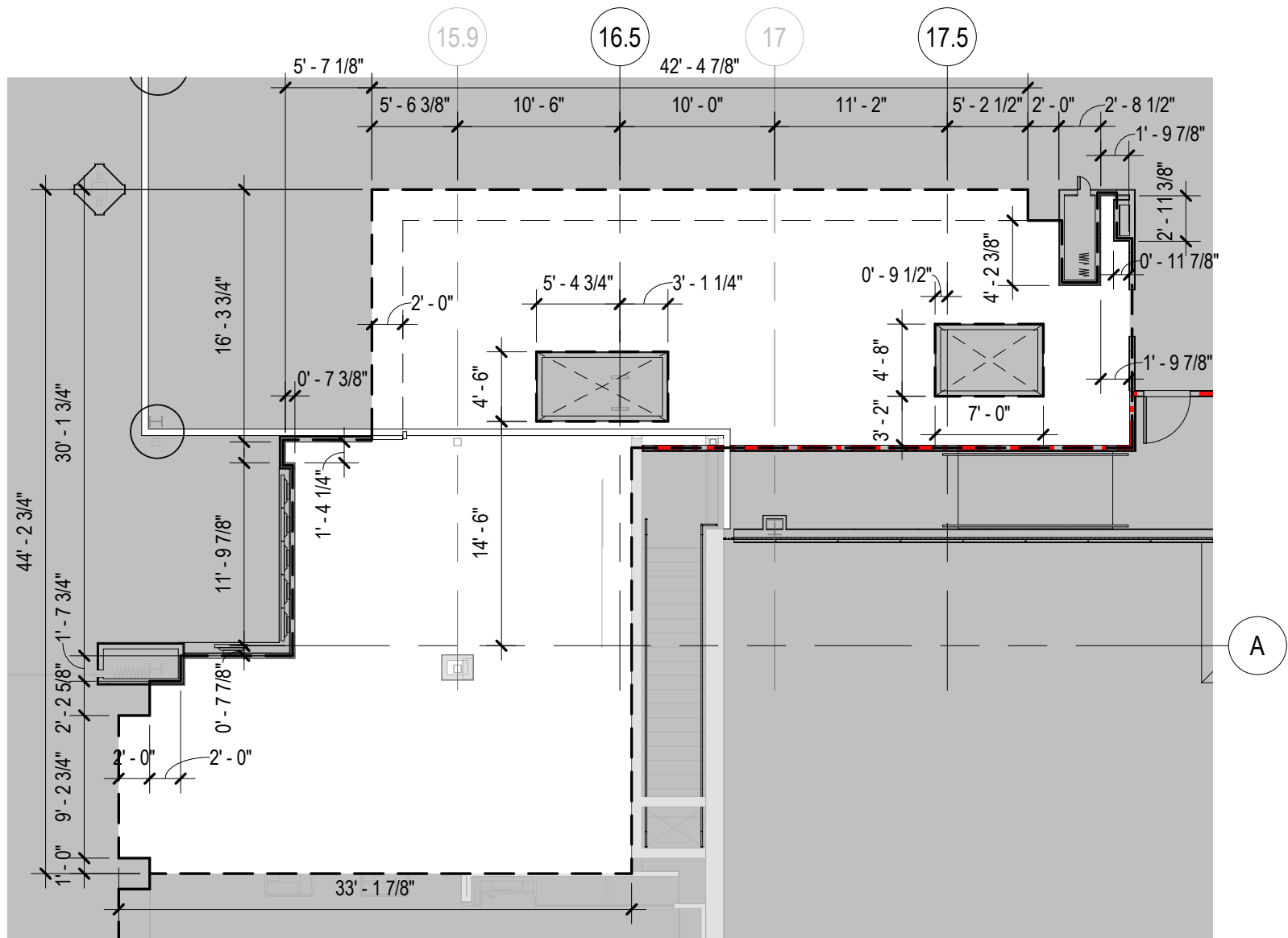




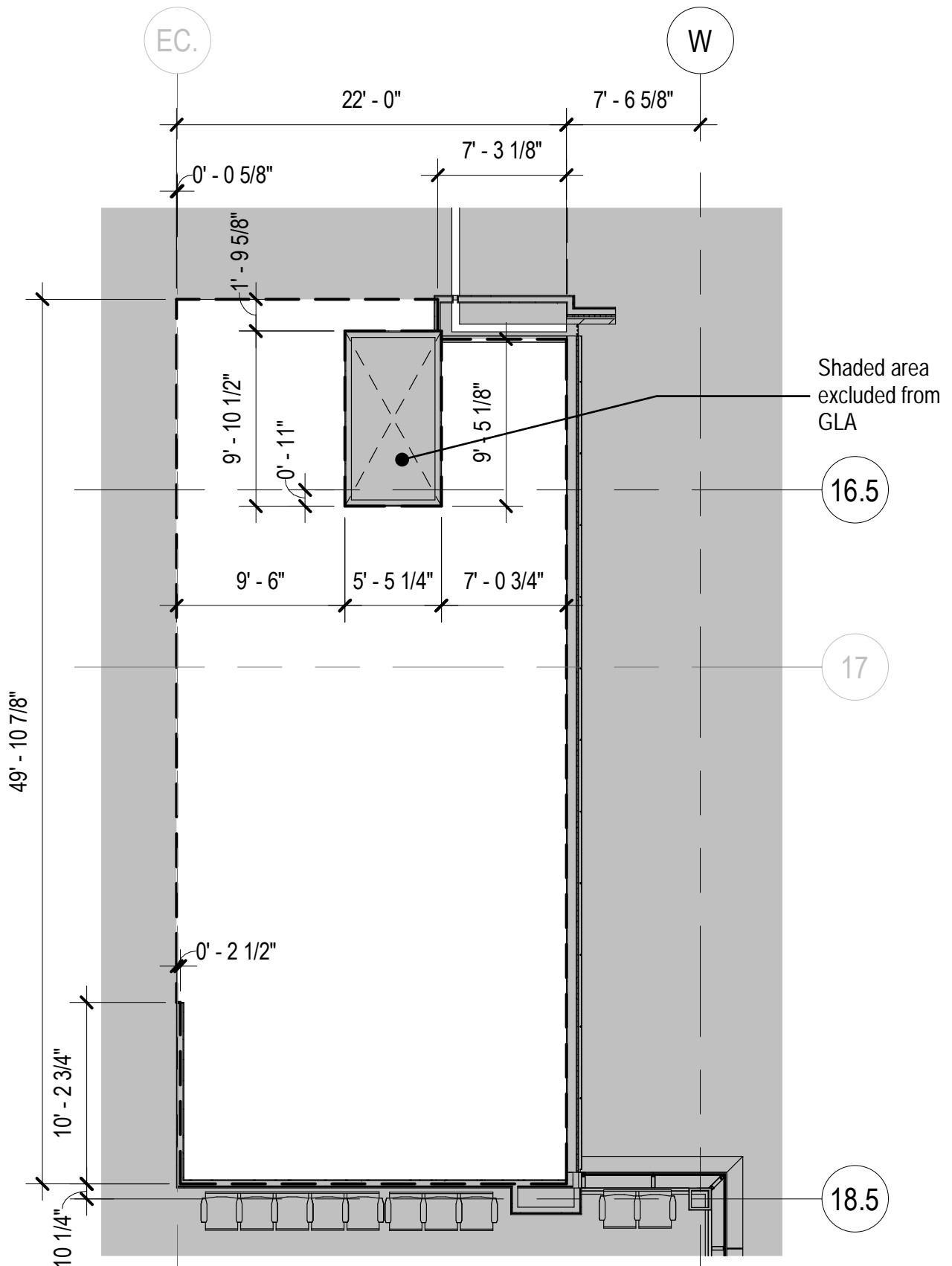
Rotunda Plan  
NTS



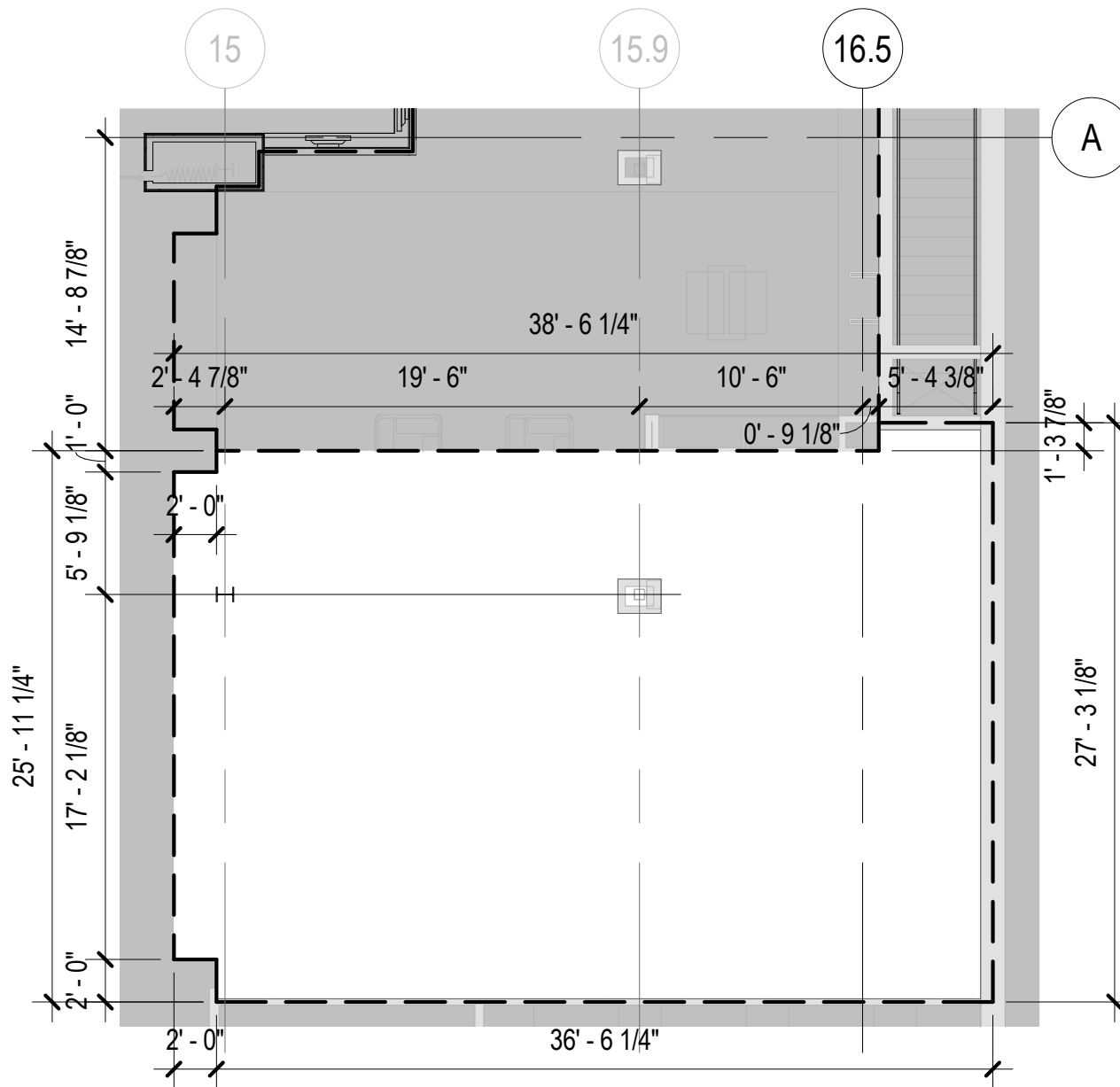
Southeast Leg Plan

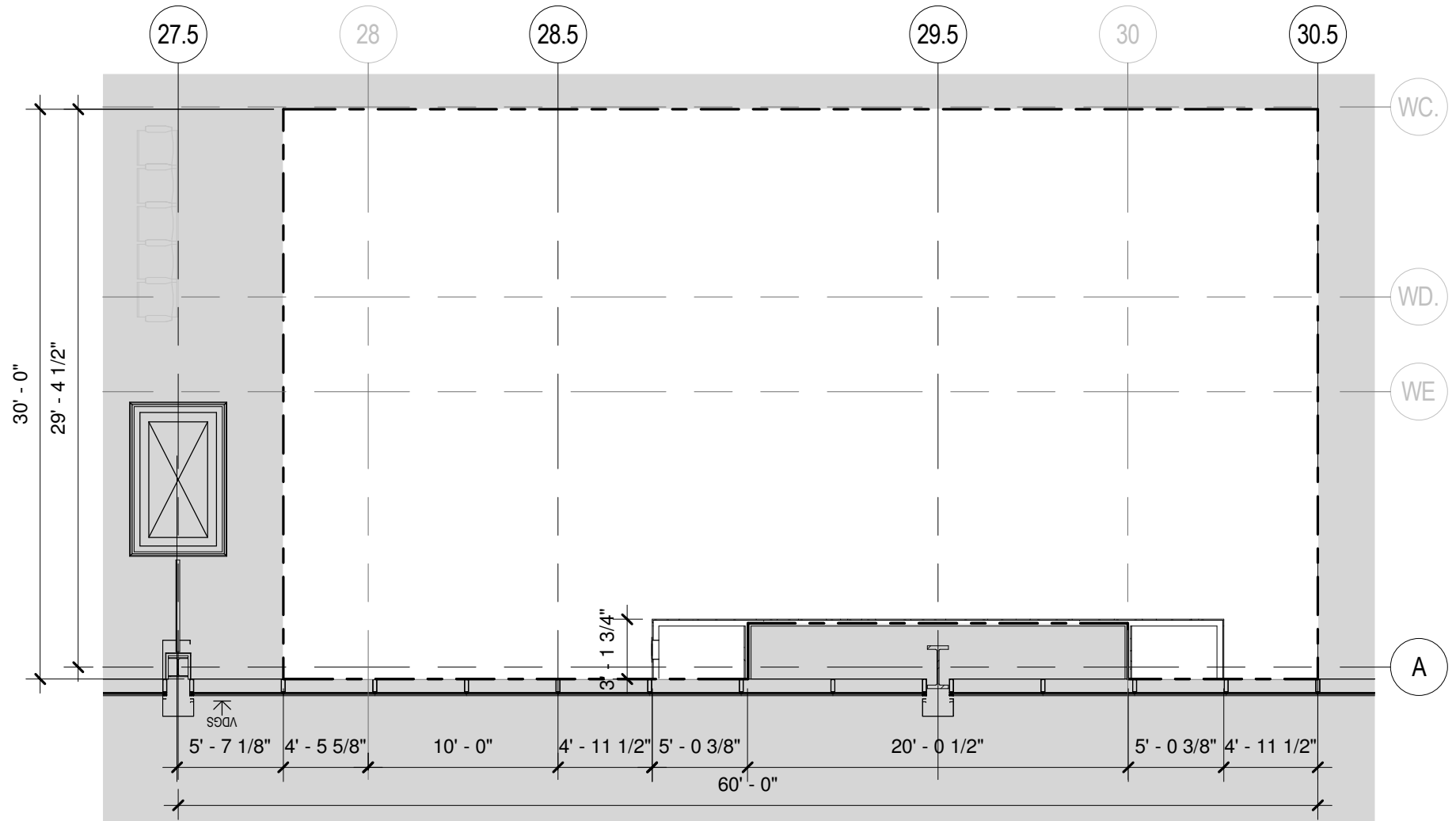
Lease Outline Drawing: Space 2-CC-101

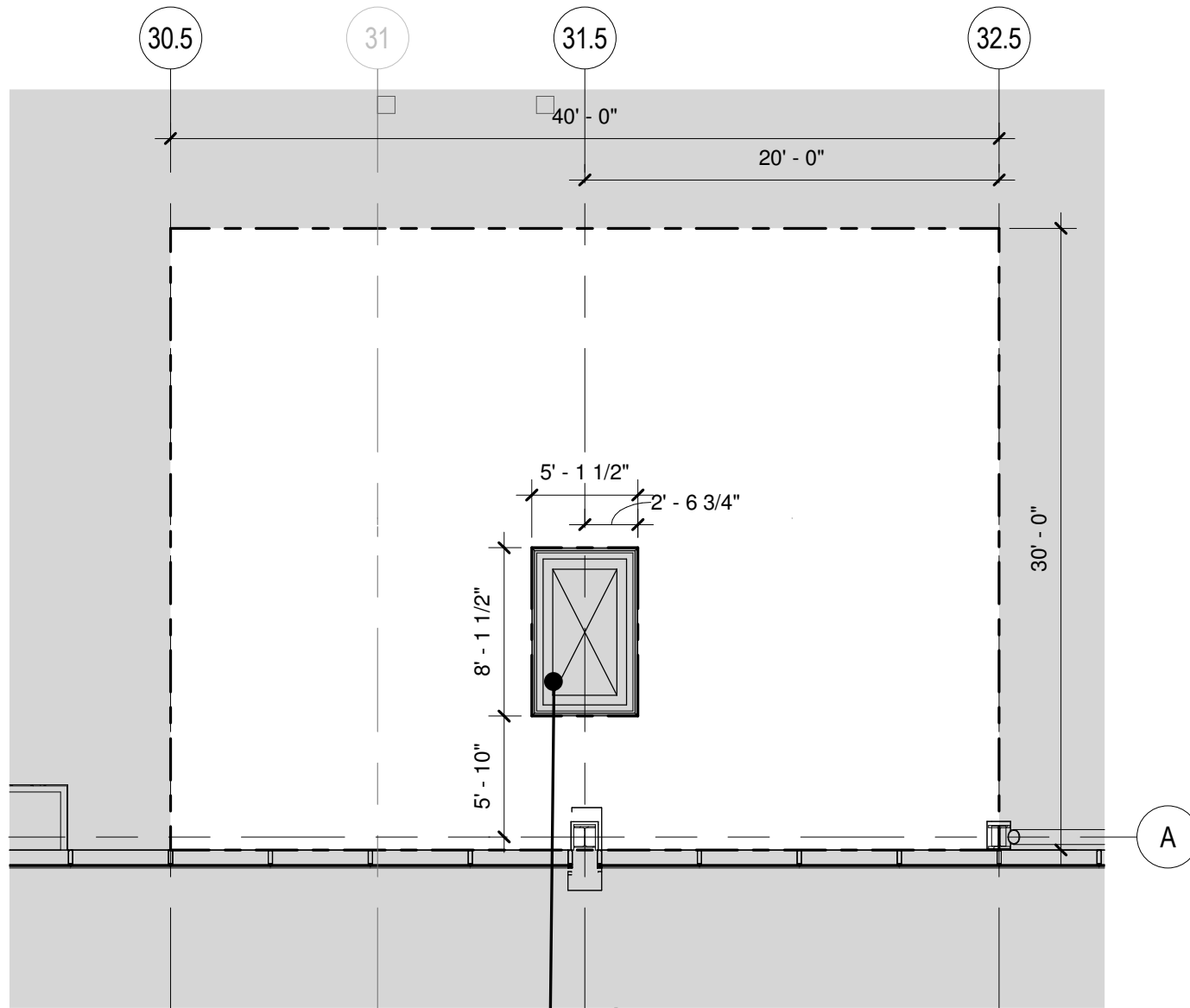


Lease Outline Drawing: Space 2-CC-108

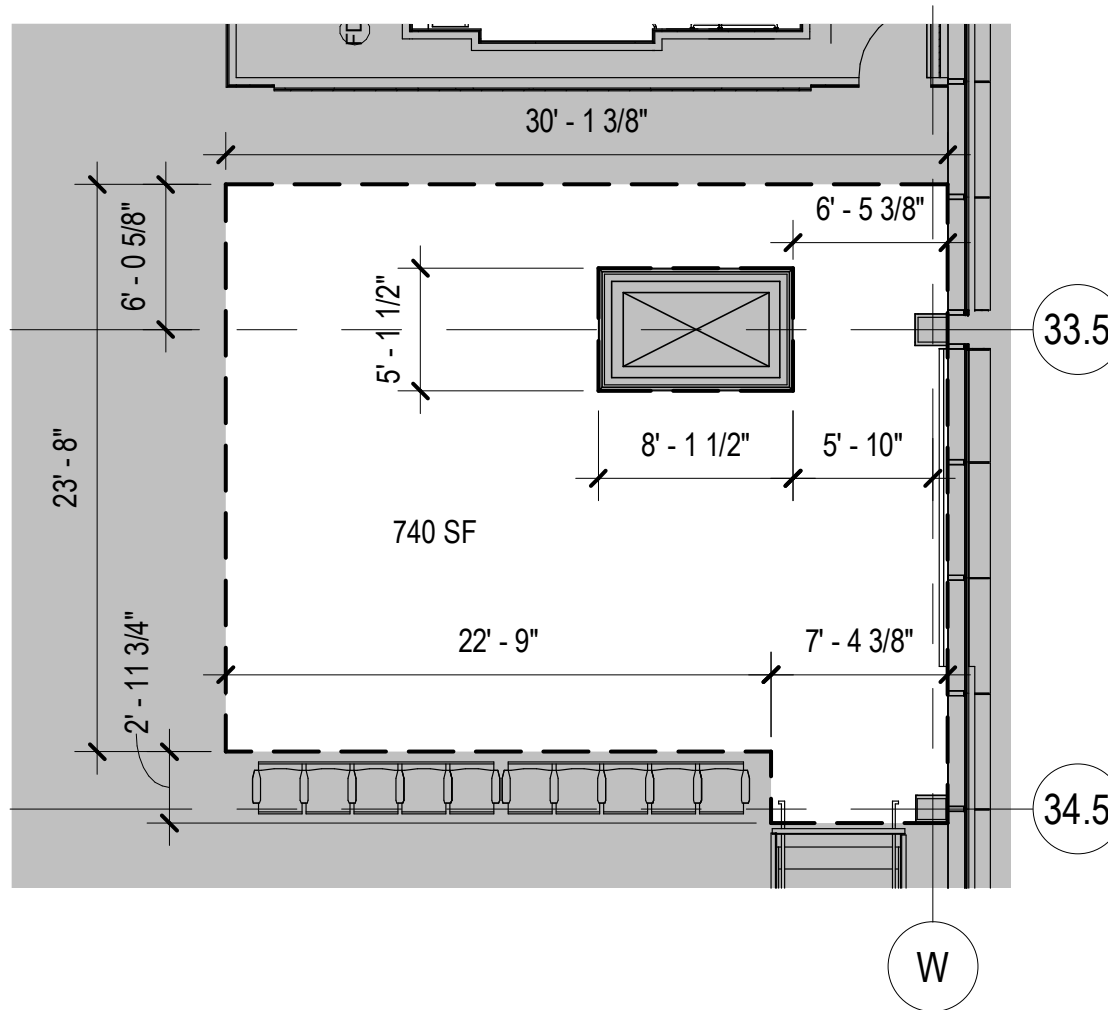
Lease Outline Drawing: Space 2-CE-101-A

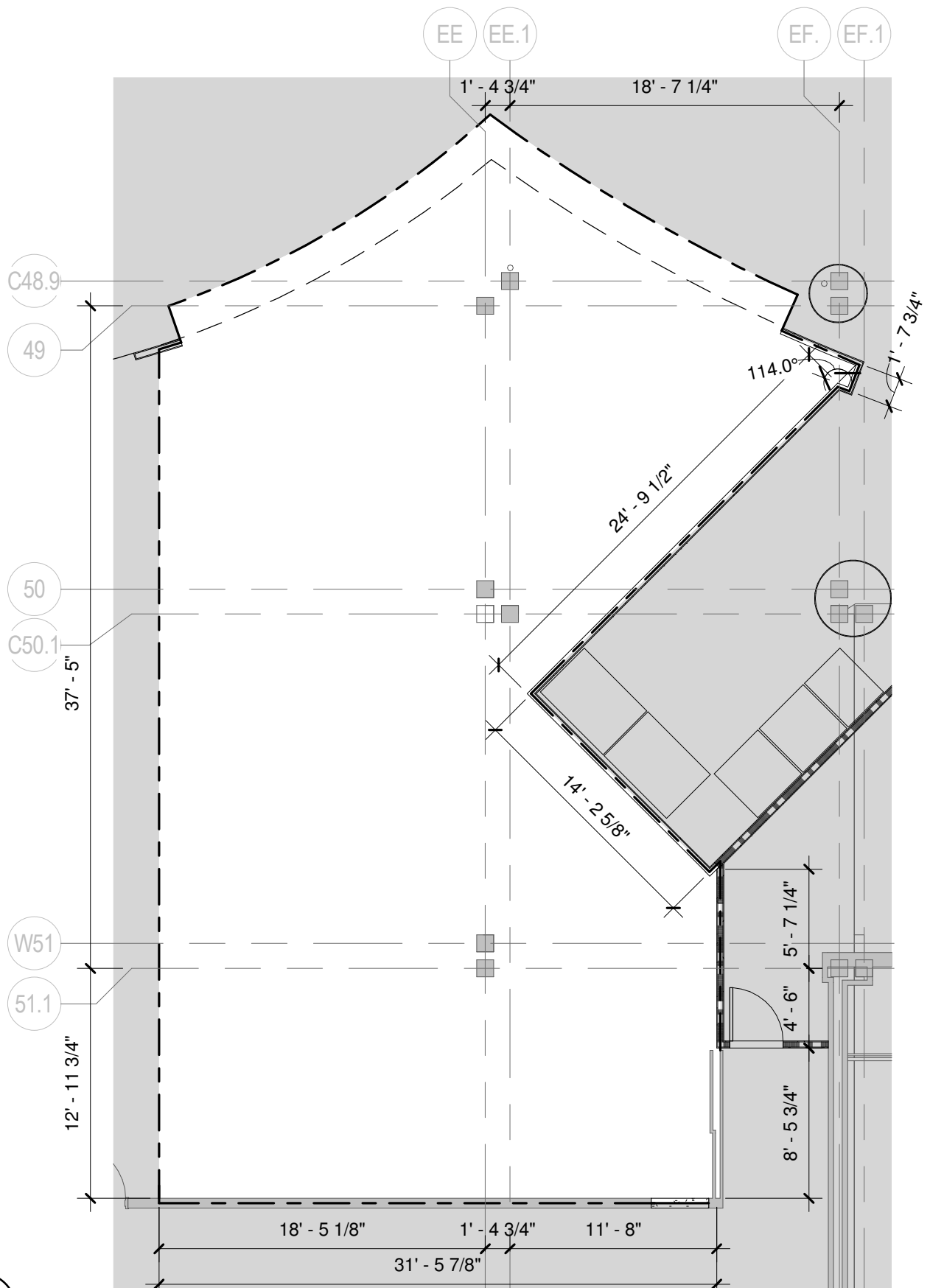

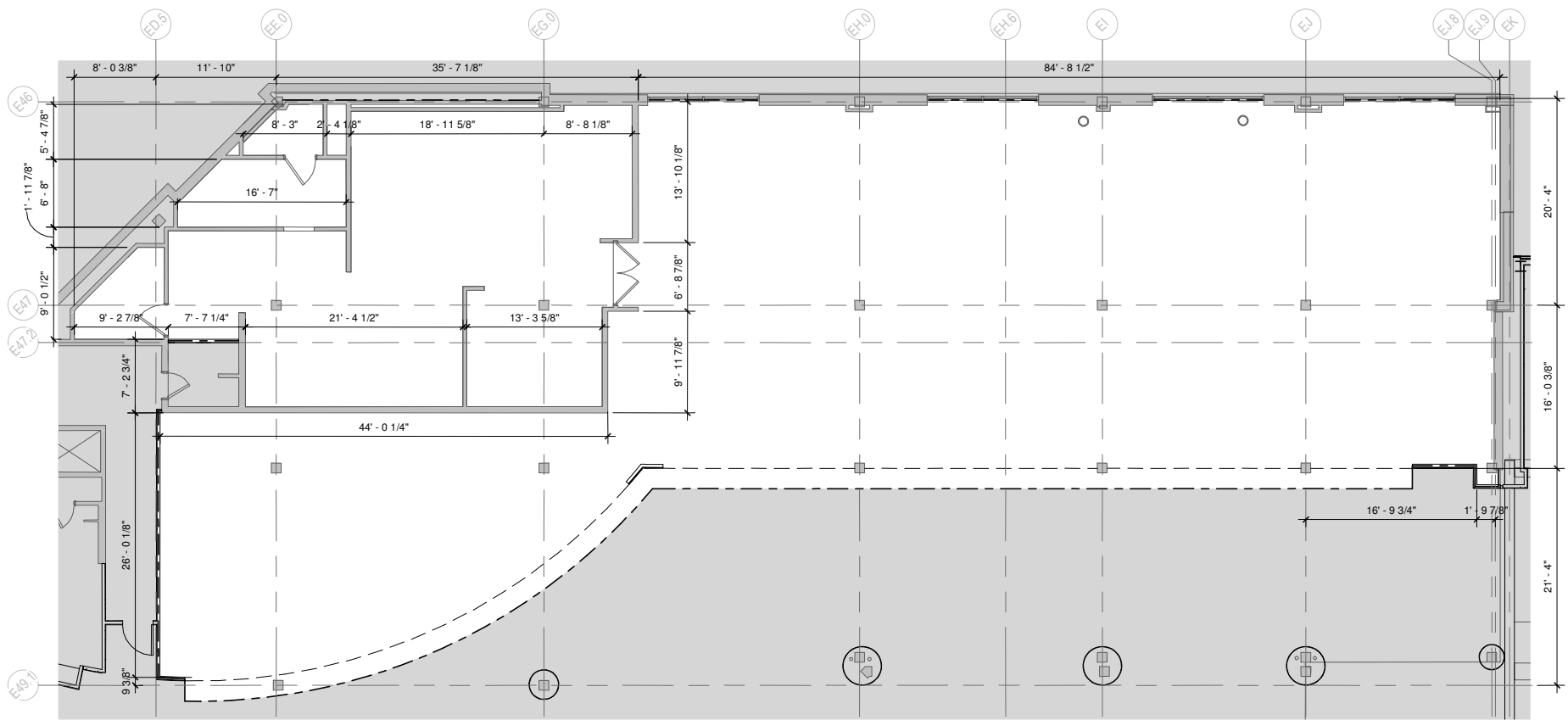
Lease Outline Drawing: Space 2-CE-113

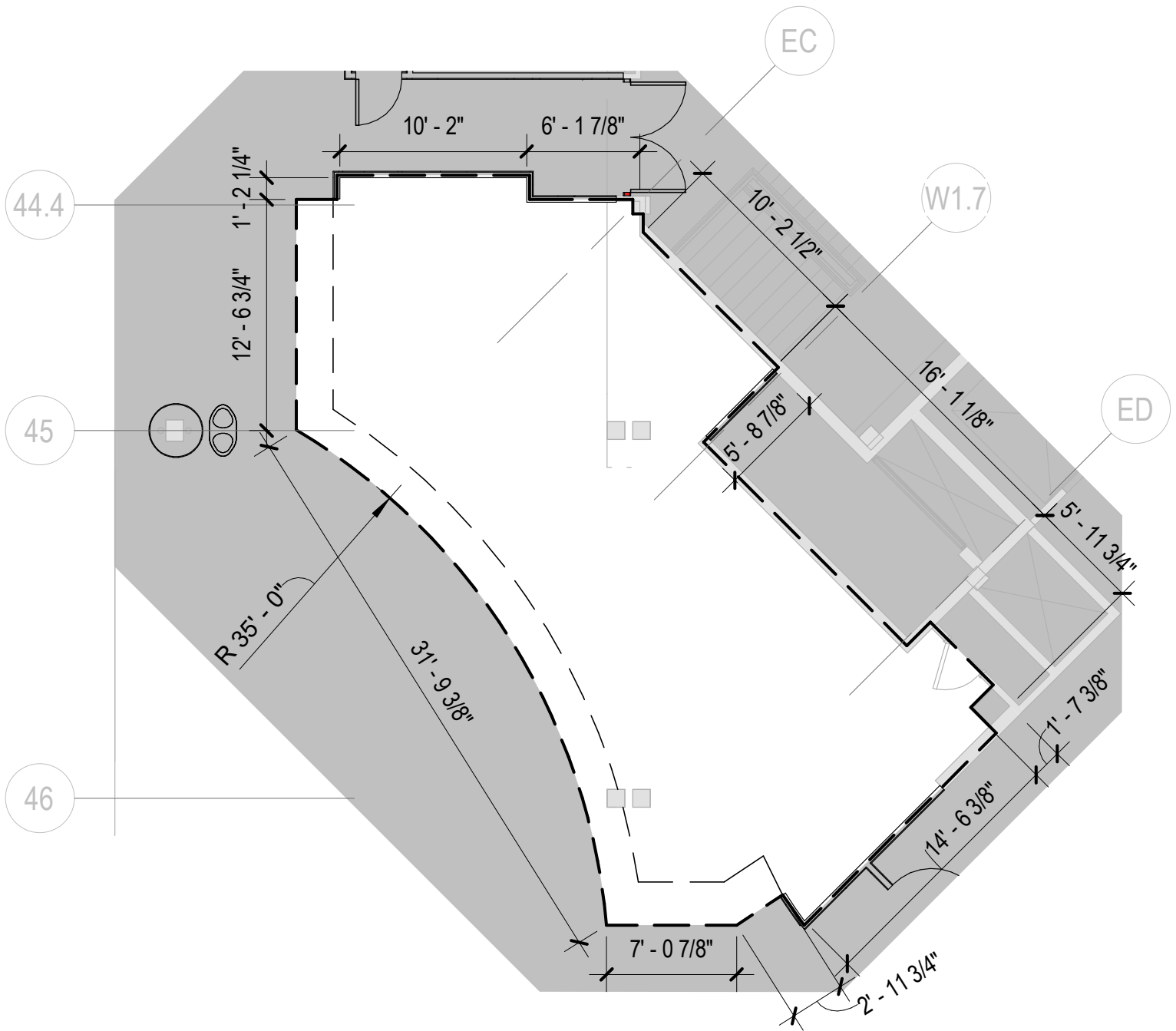


Lease Outline Drawing: Space 2-CGE103

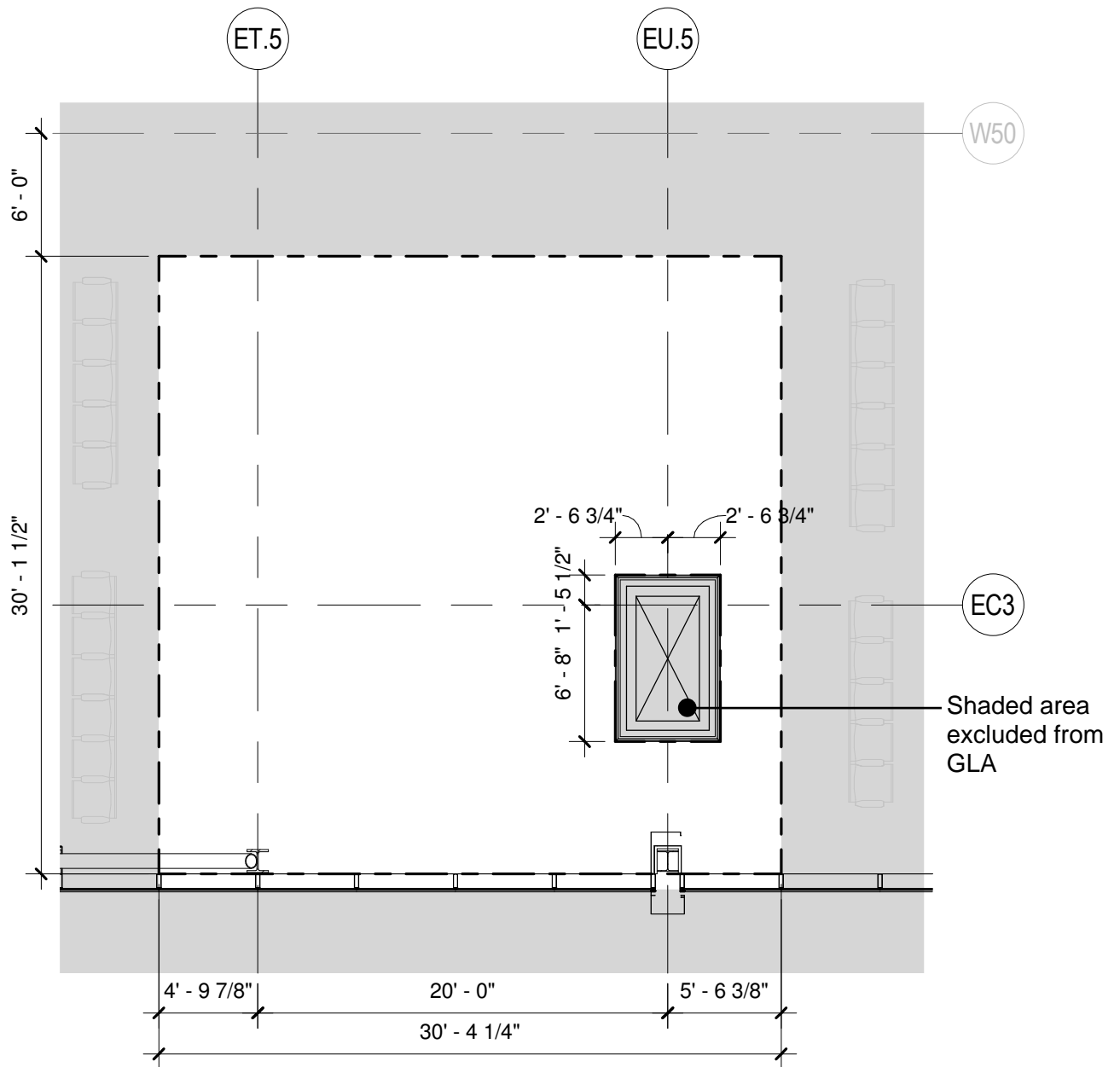

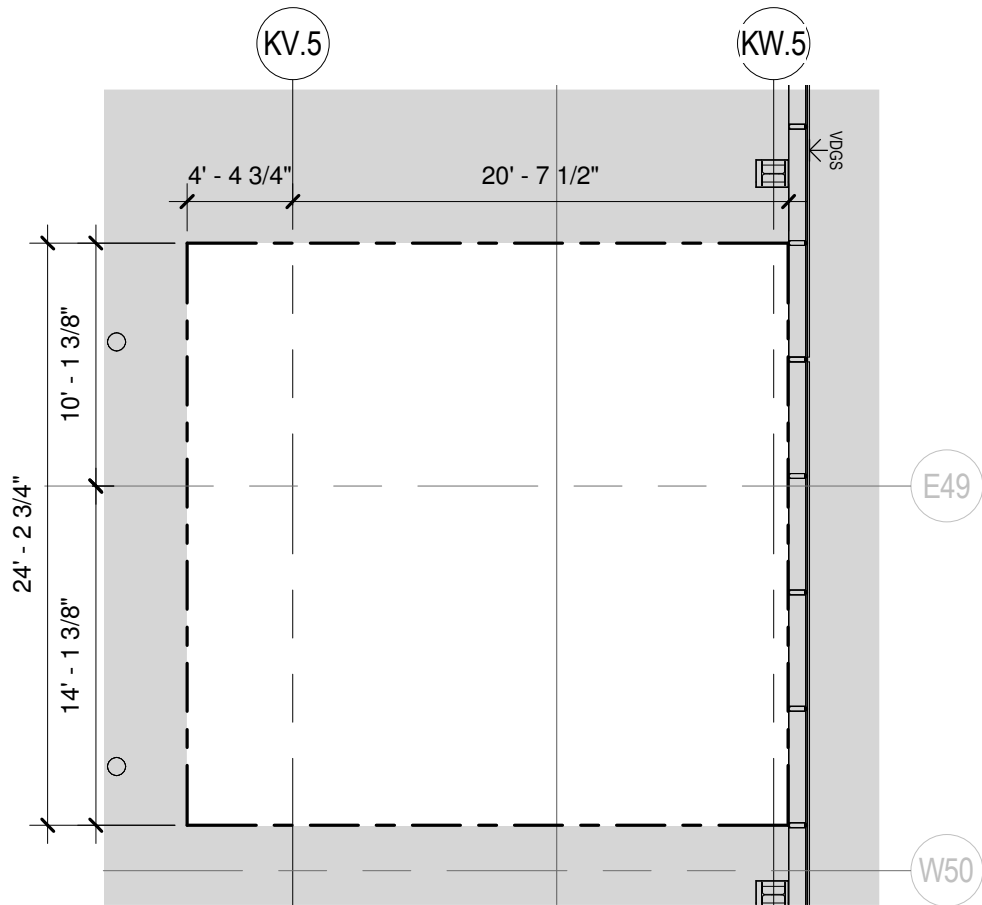


Lease Outline Drawing: Space 2-CJ-120

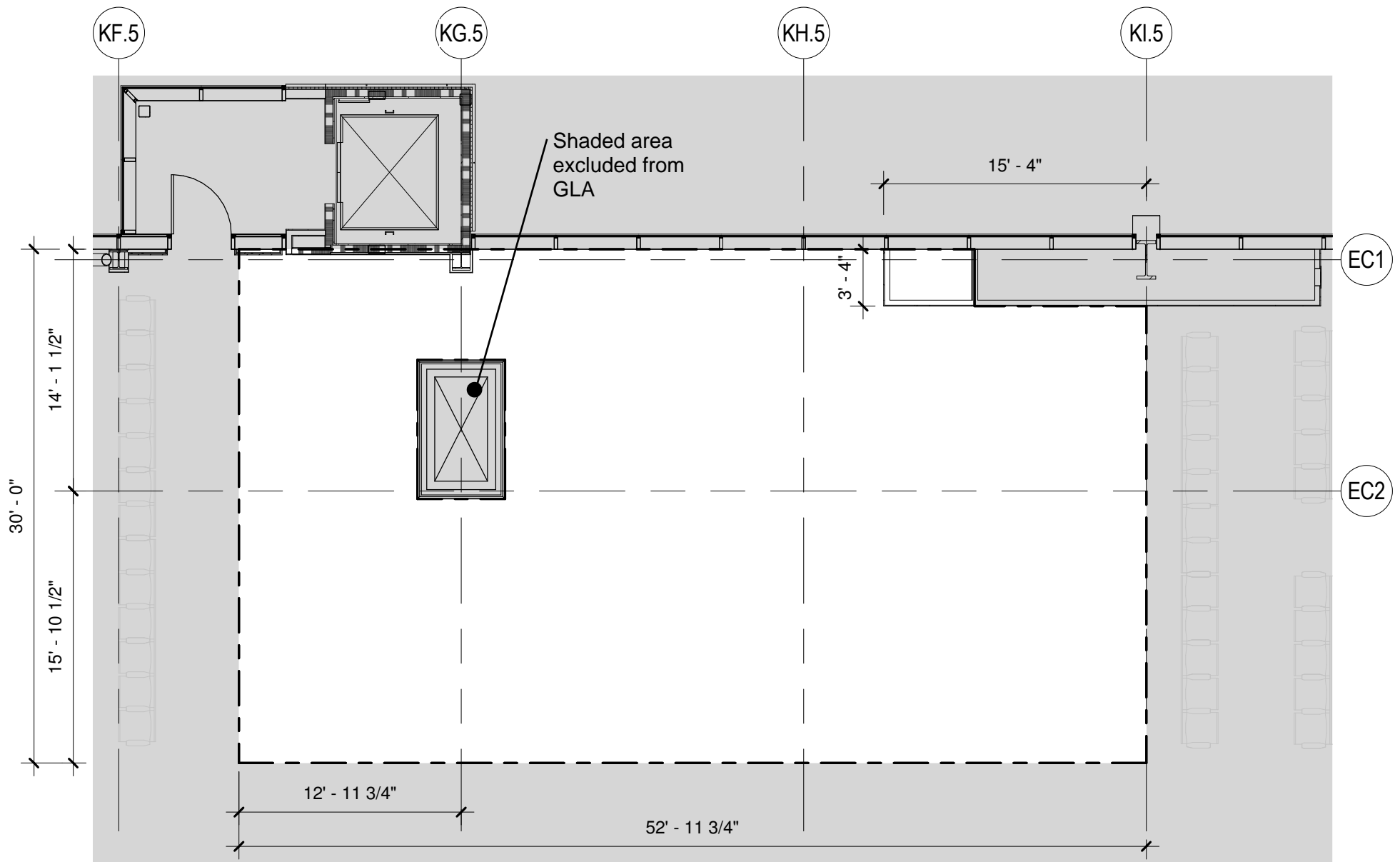


Lease Outline Drawing: Space 2-CK1-108

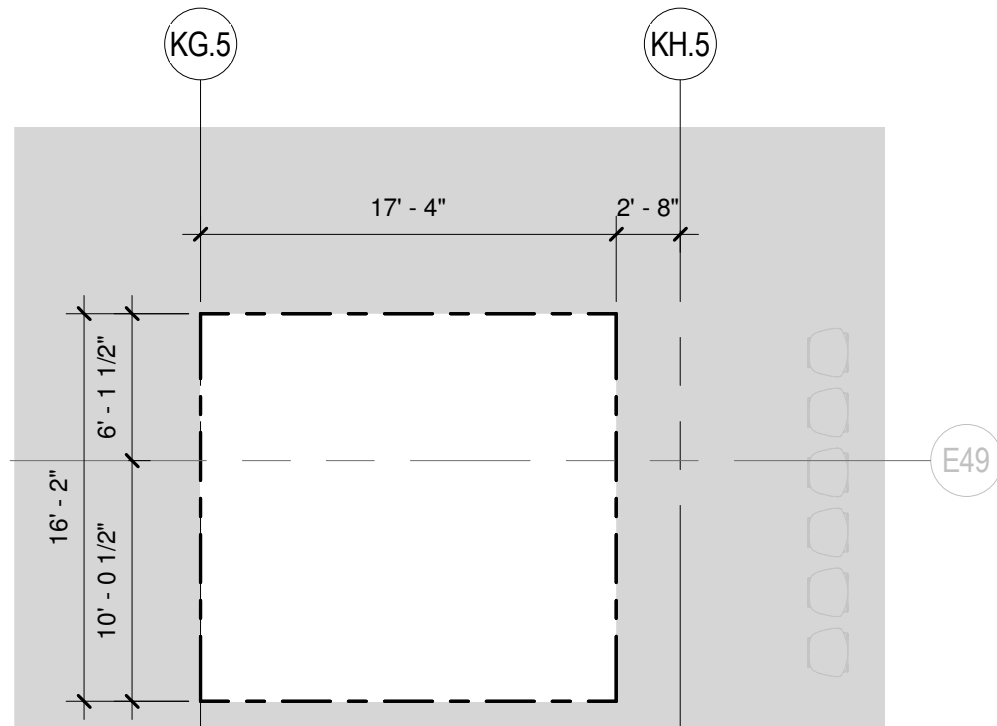

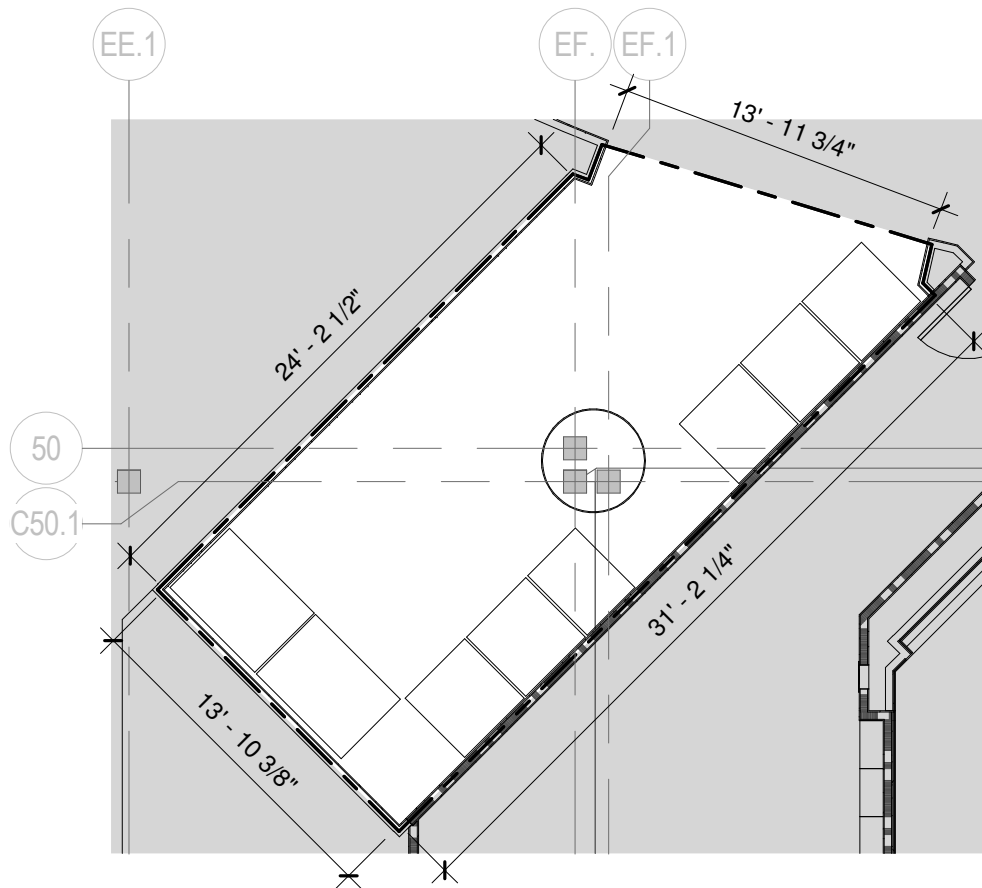


Lease Outline Drawing: Space 2-CK-115-B
