DHS will also transmit your fingerprints for enrollment into US-VISIT Automated Biometrics Identification System (IDENT).

DHS will also maintain a national, centralized revocation database of individuals who have had airport- or aircraft operator-issued identification media revoked for noncompliance with aviation security requirements. DHS has established a process to allow an individual whose name is mistakenly entered into the database to correct the record and have the individual's name expunged from the database. B. That these regulations impose a continuing obligation to disclose to the Memphis-Shelby County Airport Authority any disqualifying criminal offense. Each individual with unescorted access authority must report the offense to the Memphis-Shelby County Airport Authority and surrender the personnel identification access medium to the issuer within 24 hours of the conviction or the finding of not guilty by reason of insanity.

C. I have been advised that if a disqualifying offense has been disclosed, I will have 30 days to notify the Airport Authority or aircraft operator in writing of my intention to correct information that is incorrect. If notification to correct record is not made within 30 days a final decision to deny access will be made.

D. I have been advised that a copy of the Criminal History Records Check will be provided to me, if requested in writing, and any denial of access due to results of the Security Threat Assessment will be provided to me from the TSA through the Airport.

E. I have been advised that the MSCAA Airport Security Coordinator or a designated representative is my point of contact if I have questions about the results of the Criminal History Records Check or the Security Threat Assessment.

**1542.209.e.3** - The airport operator must verify the identity of the individual through **two** forms of identification prior to fingerprinting, and ensure that the printed name on the fingerprint application is legible. At least **one** of the two forms of identification must have been issued by a government authority, and at least **one** must include a photo.
