**THIS AMENDMENT NUMBER 4** is made and entered into this 21<sup>st</sup> day of July 2022, by and between Memphis-Shelby County Airport Authority, a body politic and corporate, organized and existing under and by virtue of the laws of the State of Tennessee ("Authority"), and Allied Universal Security Services, successor to AlliedBarton Security Services LLC ("Company" or "Sponsor").
