THIS AMENDMENT NO. 1 is made and entered into this 8th day of May, 2018 by and between Waste Management, Inc of Tennessee, (“Company” or “Contractor”) and Memphis-Shelby County Airport Authority, a body politic and corporate organized and existing under and by virtue of the laws of the State of Tennessee, (“Authority” or “Sponsor”). The Authority and the Company may be referred to herein individually as a “Party” and collectively as the “Parties”

WITNESSETH:

WHEREAS, Authority and Company entered into Contract No. 18-0113, Trash Removal Services, dated February 1, 2018 (the "Contract"); and

WHEREAS, Authority and Company agree to amend certain of the terms and conditions set forth in the Contract;

NOW THEREFORE, In consideration of the mutual covenants, agreements and conditions set forth in the Contract the Authority and Company agree as follows:

1. Exhibit B, Compensation, A cart tipper shall be added at a cost of \$329.33 per month.
2. Exhibit B, Compensation, A 4-yard recycle container shall be placed at Dewitt Spain Airport at a cost of \$68.00 per month.
3. All other provisions of the original Contract shall remain in full force and effect.
4. In the event of conflict between the terms and conditions of the Contract and the terms and conditions of this Amendment, the terms and conditions of this Amendment shall prevail.
