MEMPHIS-SHELBY COUNTY AIRPORT AUTHORITY

AND

WASTE MANAGEMENT, INC OF TENNESSEE

THIS AMENDMENT NUMBER 3 is made and entered into this 20th day of May, 2021 by and between Memphis-Shelby County Airport Authority, a body politic and corporate, organized and existing under and by virtue of the laws of the State of Tennessee (“Authority” or “Sponsor”), and Waste Management, Inc of Tennessee, (“Company” or “Contractor”). Authority and the Company may be referred to herein individually as a “Party” or collectively as “Parties”.

WITNESSETH:

WHEREAS, Authority and Company entered into Contract No. 18-0113, Trash Removal Services, on February 1, 2018, and is referred to herein as the "Contract;" and

WHEREAS, Authority and Company desire to amend the Contract as set forth herein.

NOW THEREFORE, in consideration of the foregoing and of the mutual covenants and agreements contained herein, Authority and Company agree to amend the Contract as follows:

1. Exhibit A, Section 1.1.1., equipment usage plan and equipment location list shall be deleted and replaced with the following:
 - a. One (1) 34 cubic yard self-contained compactor unit– East Rear Drive (2491 Winchester)
 - b. Two (2) 34 cubic yard self-contained compactor units– Rotunda (2491 Winchester)
 - c. One (1) 34 cubic yard self-contained compactor unit– West Rear Drive (Recycling) (2491 Winchester)
 - d. One (1) 4 cubic yard dumpster – Aircraft Rescue Firefighting Facility (2785 Rudder)
 - e. One (1) 4 cubic yard dumpster – Fuel Farm (2491 Winchester)
 - f. Three (3) 8 cubic yard dumpsters – between Cargo Buildings 3 and 4 (2491 Winchester)
 - g. One (1) 30 cubic yard open top container – between Cargo Buildings 3 and 4 (2491 Winchester)
 - h. Three (3) 8 cubic yard dumpsters – Airport QTA (2491 Winchester)
 - i. Two (2) 6 cubic yard dumpsters – Charles Baker Airport (3780 Fite Road)
 - j. Two (2) 6 cubic yard dumpsters – General DeWitt Spain Airport (2787 N. Second Street)
 - k. Two (2) 30 cubic yard open top dumpsters – MSC (4150 Louis Carruthers Road)
 - l. One (1) 8 cubic yard dumpster – MSC warehouse (4150 Louis Carruthers Road)
 - m. One (1) 30 cubic yard open top dumpster – Airfield Maintenance (3970 Hangar Road)
 - n. One (1) 4 cubic yard dumpster – US Fish & Wildlife (3150 Tchulahoma)
 - o. One (1) 30 cubic yard open top dumpster – East Cargo (4121 Runway Road)
 - p. One (1) Cart Tipper – East Dock (2491 Winchester)
