1.	Please provide the previous bid tabulations & itemized award information, including any price adjustments.
	This is our first RFB for Janitorial Supplies, so we do not have the requested information.
2.	Would you be able to provide the delivery quantity breakdown per each item?
	The delivery quantity breakdown will be based on our business needs.
3.	We have noted regarding scope of service "Supplier must be able to warehouse inventory and deliver on a Just In Time (JIT) schedule." may we know what time frame is "just in time"?
	Just in Time delivery time frame means within 24 hours.
4.	Can you send specs or pictures of the dispensers currently hanging in the bathrooms for the following:  Soap dispensers  Toilet tissue dispensers  Roll towel dispensers  Or can we schedule a site visit to see what is currently in use? Additionally, are you interested in getting new dispensers?
