THIS AMENDMENT NUMBER 9 is made and entered into this 9th day of March 2023, by and between Memphis-Shelby County Airport Authority, a body politic and corporate, organized and existing under and by virtue of the laws of the State of Tennessee ("Authority"), and S K B Facilities and Maintenance, Inc. ("Company" or "Contractor"). Authority and Company may sometimes be referred to herein individually as "Party" or collectively as "Parties".

WITNESSETH:

WHEREAS, the Parties entered into Contract No. 18-0117 for Janitorial Services on May 1, 2018, and is referred to herein as the "Contract;" and

WHEREAS, Authority and Company desire to amend the Contract as set forth herein.

NOW THEREFORE, in consideration of the foregoing and of the mutual covenants and agreements contained herein, Authority and Company agree to amend the Contract as follows:

1. Exhibit B, Schedule of Compensation/Conflicts of Interest, shall be revised by the following:
Year 6, Column D, shall have a total cost of \$3,103,588.73.
2. Exhibit A, Scope of Services, shall be revised by adding the following:
1.5.13 Employee Compensation
Company shall compensate all employees at a rate of not less than \$15.00 per hour.
3. All other terms and conditions of the Contract and any subsequent amendments shall remain in effect as they are currently stated.


